R1 (Water)	Residential Services (per unit)	\$60.00 base charge per unit, includes up to 15,000 gallons of use per quarter. Additional use beyond 15,000 gallons per quarter is billed at \$3.00 per 1,000 gallons.
R2 (Water)	Residential Non-Metered (Temporary)	\$83.00 per month
R3 (Water)	Account in Violation Residential Services – Out of Date Meter (per unit)	\$120.00 base charge per unit, includes up to 15,000 gallons of use per quarter. Additional use beyond 15,000 gallons per quarter is billed at \$3.00 per 1,000 gallons.
R11 / S4 (Irrigation)	Residential Irrigation Use (per irrigation meter)	\$60.00 base charge per meter \$3.25 per 1,000 gallons of water use Irrigation use not applicable for sewer charges
W1R1 (Sewer)	Account in Violation Sewer available within 400 ft, but not yet connected to property	\$9.30 per 1,000 gallons of water use
WWR1 (Sewer)	Residential Single-Family account discharging to sewer system	\$7.92 per 1,000 gallons of water use
WWR3 (Sewer)	Residential Multi-Unit property discharging to sewer system	\$8.80 per 1,000 gallons of water use

Unauthorized Use of Fire Hydrant	\$250.00 per occurrence or the cost of actual damages, whichever is greater
Tampering with Precinct Property	\$500.00 per occurrence or the cost of actual damages, whichever is greater
