Project Status

Asset Management

I met with our consultant (Wright-Pierce) yesterday to finalize the scope for 2022 Asset Management projects. We should have a scope to approve at your next meeting. We also have set up our first visit with Rayburn Utility Solutions, our consultant who will be working with us to define our needs and goals for, as well as guide us through our selection of, asset management software. Rayburn will be here on September 15th to get things kicked off.

Well 2R

We're ready to close out the project officially with the Drinking Water Groundwater Trust Fund. That will be happening over the next couple of weeks. Ell (SCADA techs) will hopefully be finalizing the connection between Well 2 and our SCADA system shortly.

Sludge Dryer

Saco River Erosion No change.

WWTF Aeration Upgrades No change.

Cranmore-Artist Falls Water Main

Results from the soil borings on August 4th are very promising and we believe we'll be able to directionally drill the northern portion of the new water main between Skimobile and the somewhere in the vicinity of the new hotel.

We are meeting with AJ Coleman after the meeting today to go over the location of the proposed pipe crossing under the Rec Path in that area so that they can install those few lengths of pipe now and avoid disturbing the Rec Path in the future.

Country Road Sewer

No change. **Pine Hill Franchise Area**

No change – the Precinct's attorney is assembling the PUC application.

Fuel Supplier Change

We were contacted by Dennis K. Burke this past week, who notified us that Eastern Propane is leaving the gasoline/diesel business and will no longer be providing fuel to the Precinct. Eastern passed their customer list on to Burke, who has the State of NH contract for fuels. We are working with Burke to see what our new pricing will be and may explore other options once the Town gets their fuel bids back in September.
