Well #5 Update

Cleaning has been completed on Well #5. Looking at the before/after videos of the well screen, the cleaning has made a significant difference. Our well screen, which you could barely see before the cleaning, appears to be in excellent condition and the pumping capacity of the well appears to have been restored to its original yield. We anticipate the contractor wrapping up with installation of the new pump/motor/column by early next week, with the well coming back online by the end of next week.

2020 Lobbying Contract

Bill Hounsell has submitted a proposal for 2020 lobbying efforts on behalf of the Precinct. His total fee remains at \$18,000 per year, charged incrementally on an hourly basis. In 2019, Bill charged \$14,500 of the \$18,000 contract. I would ask for a motion to allow me to sign Bill's contract for the 2020 year.

Large Groundwater Withdrawal Permit Renewal

Our LGWP for Well #6 is due for renewal by the end of March. Well #6, being the newest "new" well in the Precinct, is subject to periodic renewal of our permit to withdraw water. Geolnsight, our groundwater hydrology consultant who has done extensive work in the Precinct with both Well #2R and to reduce monitoring requirements associated with our Well #6 permit, has submitted a proposal in the amount of \$8,500.00 to perform all work associated with the permit renewal. I would ask for a motion to allow me to sign the Geolnsight proposal so that work may be completed on time.

2020 Budget Update

It has been a very challenging road to get to this point, but our first draft budgets for 2020 are ready for their initial presentation and attached to this report. Hannah and I have spent a significant amount of time working with our accountant, auditor, and new financial software provider to modernize our budgeting and accounting practices. This year's budgets do a number of things differently than in previous years in order to present information in a transparent, easy to understand format. As part of the software conversion, account numbers and classifications have been standardized across funds. Individual expenses have been examined and, in many cases, moved to more appropriate budget lines. In this initial year the account and formatting changes may appear different but are more closely aligned with modern accounting standards. Being first drafts, I welcome feedback on their presentation/format.

North Conway Fire Expansion Committee

Commissioner Nelson reported that the NCFDEC have been meeting every other week and are making good progress. Chief Preece and REI are working on an interim plan for a Fire Station should the Article pass at Annual Meeting. The Committee has talked about structural design and aim to start construction in the fall, with a groundbreaking in August. The committee is looking to expand its members and are currently in the process of finding where to store the trucks in the cold weather before they're able to be stored in the new Fire building on January 1, 2021.
