Because the water entered the customer's property and then did enter the sewer system, the Precinct did incur the cost of both providing and treating the water and an abatement for any portion of the water use cannot be recommended.

DWGTF Update

On Tuesday I attended the DWGTF Advisory Commission meeting. I'm pleased to say that our Well #2 project was voted on by the full committee to be advanced for funding. There is still one final meeting where the entire slate of recommended projects will receive official funding approval, but things look excellent as of now. Our funding request as slated to be approved includes \$790,000 in loan and \$300,000 in grant funds. Following final approval in December, we will begin the process of planning for a 2020 construction timeline.
