1. Rates: A schedule of rates currently in effect is attached hereto and made part hereof. Customer understands that the established rates, buy-ins, and service regulations of the North Conway Water Precinct are subject to change.
2. Billing: Bills for water and/or wastewater shall be rendered quarterly for residential services and monthly for commercial services, and are due and payable upon receipt. Water and/or wastewater bills become delinquent if not paid within thirty (30) days from the date of billing. Customer agrees to pay all late charges, to include costs of collection and reasonable attorney fees.
3. Term: The parties' obligations shall commence on the date when the Precinct begins to supply service providing applicable Buy-In Fees are paid in advance hereunder and shall continue until either party shall have received from the other written notice to discontinue service.
4. If Tenant is the applicant, the Landlord / Property Owner must date and sign application.
